The Head of Chancery, High Commission of India Islamabad on behalf of the President of India invites sealed bids from reputed firms / distributors of sound/music systems in Pakistan for the work of following description at the High Commission of India, G-5, Diplomatic Enclave Islamabad, Pakistan.

Description of Work:

For the **“Supply, installation, commissioning and maintenance of Multipurpose sound system for speech, movie & presentation”**, keeping in views the acoustics of the auditorium the following are the specifications desired for the Auditorium of the High Commission of India, G-5, Diplomatic Enclave Islamabad, Pakistan:

- (a). 1 configurable power amplifier for speakers,
- (b). 1 configurable power amplifier for woofers,
- (c). 4 surface mount environmental speaker for surround,
- (d). 1 surface mount speaker for center,
- (e). 2 bass speaker,
- (f). 2 surface mount speaker for left + right,
- (g). wall bracket for speakers
- (h). 1 mixer 10 mic, 2 stereo input,
- (i). 4 hand held cordless microphone,
- (j). 6 collar cordless microphone,
- (k). 1 head gear cordless microphone,
- (l). 1 goose neck microphone,
- (m). 1 goose neck microphone stand,

- (n). 1 multi-channel AV pre amplifier,
- (o). Interconnect cable, Connectors, as per requirements.

4. Bid(s) will be opened on February 6, 2017 at 5.00 PM in the High Commission of India, G-5, Diplomatic Enclave, Islamabad in the presence of the tenderer(s) or their authorized representative(s) who are present.

5. The High Commission of India reserves the right to accept or reject any or all tenders either in part or in full without assigning any reasons thereof.

6. This INVITATION TO TENDER will form part of the Tender Documents

INSTRUCTIONS TO TENDERER

1. Eligibility Criteria:

The Agencies/contractors that fulfill the following requirements shall be eligible to apply. All documents required in support of eligibility along with Tender Document Fee and EMD shall constitute the bid and will be submitted as such.

- i) **Experience:** The tenderer should have an experience of at least three (03) years in installations of sound systems in Auditoriums/ halls.
- ii) The tenderer should be a reputed and authorized dealer of branded and internationally reputed brands such as Bose, Sony, Beats etc.
- iii) The Tenderer should have service/maintenance facilities and staff in Islamabad to fulfill the requirements of the contract.
- iv) The bid of any tenderer(s) who has not complied with one or more of the conditions of eligibility criteria are liable to be summarily rejected.

2. Earnest Money Deposit

The bidder shall be required to deposit the earnest money (EMD) for an amount of PKR 60,000 (refundable) by way of demand draft made in favor of High Commission of India, Islamabad.

The Earnest Money Deposit may be forfeited:

- (a) If a Bidder withdraws, modifies, revises, deviates, its bid during the period of bid validity specified by the Bidder on the Bid Form; or
- (b) In case of a successful Bidder, if the Bidder fails to furnish order acceptance within 14 days.

The EMD should be valid for a period of 90 days from date of opening of tenders.

The Client is not liable to pay any interest on such an amount submitted as EMD.

The demand drafts for earnest money deposit & tender processing fee must be enclosed in the envelope containing bid. Any bid without the demand drafts of earnest money deposit and tender processing fee will to be rejected.

After the award of contract to the successful tenderer, the earnest money deposit of all other Bidders shall be returned within 30 days.

3. Tender Processing Fee

The Tender fee is PKR 1,000

The Tender Fee is non-refundable and is payable in the form of a demand draft drawn in favour of "High Commission of India, Islamabad "

The Tender Fee must be enclosed in the Bid Package failing which the bid will be rejected.

4. Warranty / Guarantee:

The tender must be quoted with a minimum three years' warranty on construction, supplies and equipments and from the date of the practical completion against the defect of any workmanship and poor quality.

5. Payment

Payment of the 90 % of the total order value shall be released after completion of work. 10 % shall be released after 3 months of satisfactory performance, verified by the buyer's technical team.
