

CHECK LIST OF DOCUMENTS FOR RE-ISSUE OF PASSPORT

Please put all documents in the following order below the checklist. The applicant should come personally at the High Commission for submitting the application, during public hours on any working day.

1	<input type="checkbox"/>	Passport Application form (two sets) with photograph & Signature/thumb impression
2	<input type="checkbox"/>	Personal Particular Form (two sets) of the applicant and one for spouse (if married) with photograph & signature/thumb impression
3	<input type="checkbox"/>	Original and copy of the Passport
4	<input type="checkbox"/>	Affidavit certifying that the applicant has not applied for Pakistani or any other nationality in English If applied for Pakistani citizenship, an affidavit is required certifying that the same has not yet been obtained at the time of the application of the Passport. Further, a letter is required from Ministry of Interior, Government of Pakistan certifying that the case of citizenship is pending with the Government of Pakistan. The letter must be duly signed by Ministry of Interior and attested/apostilled by Ministry of Foreign Affairs (MoFA), Pakistan
5	<input type="checkbox"/>	Address proof viz. recent electricity bill or telephone bill or gas bill [If the name of the applicant is different than the name mentioned in the utility bill, an affidavit is required mentioning the relation with the person whose name is mentioned in the utility bill and also submit the copy of his/her CNIC card (show original) along with its notarized English translation]
6	<input type="checkbox"/>	Copy of valid visa and/or Resident Permit (RP) [RP must be attested/apostilled by MoFA, Pak] [If the valid visa is not affixed in the passport, the letter issued by the Ministry of Interior, Pakistan is required mentioning the duration of the valid visa and it must be attested/apostilled by MoFA]
7	<input type="checkbox"/>	If married to a Pakistani, a copy of Marriage Certificate (MC)/ 'Nikahnama' (a notarized English translation is required if MC is in Urdu) must be attested/apostilled by MoFA, Pakistan (in case MC issued in Pakistan) OR attested/apostilled by the Ministry of External Affairs, India (in case MC issued in India) {Bring Original Marriage Certificate in both cases}
8	<input type="checkbox"/>	If married to a Pakistani, Original and copy of passport & CNIC of spouse of the applicant with notarized English translation of CNIC
9	<input type="checkbox"/>	Two (2) extra passport sized photographs
10	<input type="checkbox"/>	Fees : Pak Rs. 4500/- + 211/- (contribution towards ICWF) for 36 page booklet. Pak Rs. 6000/- + 211/- (contribution towards ICWF) for minor below age of 18 years
